REQ-2022-016 – A request by Consolidated Water Power Co, owner, to amend the Town of Linwood Comprehensive Plan Future Land Use Map designation of 2.073 acres included in parcels 024230808:06.14 and 024230808:06.15 from L3 Limited Agriculture/Mixed Use to Industrial; and a request to amend the zoning classification of the same area from A4 General Agricultural to Industrial.
